Dear Parents,

You had indicated that your child would be utilizing the bus for the 2007-08 school year. We are pleased to offer the following bus service through Akina Bus Service.

Pick-up & Drop-off Locations (see attached time table for schedules):

Kihei (Kalama Park Lot, near play structure)
Ma'alea Junction (Maui Ocean Center Parking Lot)
Wailuku (War Memorial Gym parking Lot)

The annual cost for the service will be as follows:

Wailuku/Ma'alea Round-Trip:	\$1,225.00
Wailuku/Ma'alea One-Way:	\$ 765.00
Kihei Round-Trip:	\$1,715.00
Kihei One Way:	\$ 965.00
*Individual One-way Bus Passes	\$ 6.00

*Bus passes are issued on a space available basis. They can be purchased through the Business Office, Mrs. Tisinger, and Mrs. Sandoval whose offices are located in Cooper House; the Middle School Assistant and Mrs. Smith in the Upper School Office.

Due to limited number of seats available, we need a firm commitment from you to secure a place for your child(ren) on the bus. Please complete the Transportation Agreement and return it to the Business Office no later than August 7, 2007. Confirmed spaces will be filled on a first come first served basis. If your plans have changed and you no longer require transportation, kindly notify the Business Office. Thank you for your cooperation.

Please note that inappropriate behavior will not be tolerated on the bus. Enclosed with this agreement is a "Behavior Contract" entitled Seabury Hall Bus Rules. Please review these rules with your child(ren). You and your child(ren) are required to sign this contract and return it with this agreement. Non-compliance with the rules will result in a warning and work duty. Repeated discipline problems will lead to suspending bus service to the offender. There is no refund of bus fees if service is suspended for disciplinary reasons. These rules are necessary for the safety of all passengers.

Deadline for the transportation fee is August 10, 2007. If you require special arrangements, please contact me at your convenience.
